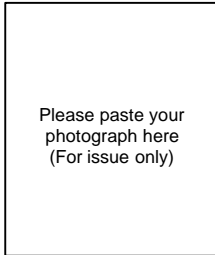

 - The successful flight test report from the Authority's Designated Flight Examiner, (as appropriate).
 - Applicants must be fully conversant with the Singapore ANO, AIC and NOTAM.
 - Two recent full faced photographs of size 25mm X 30mm with your name printed on the back.
- You will be notified in writing when your licence is ready for collection.
