This form, when completed, may either be mailed or presented to the CAAS Flight Operations Section, Singapore Changi Airport P O Box 1, Singapore 918141, after you have ascertained from CAAS that your medical has been assessed as “fit” by the Civil Aviation Medical Board. You should be able to collect your renewed Certificate of Validity when you submit this application at CAAS.
3. Crossed cheques should be made payable to “Civil Aviation Authority of Singapore”. Please note that our operating hours are as follows:

4. You need not present your log book unless CAAS requests you to do so.
5. Applicant must be fully conversant with the Singapore ANO, AIC, and NOTAM.

You may collect your licence at the Airworthiness / Flight Operations office during office hours or request for it to be delivered by post. For postal delivery, you must provide a self-addressed envelope. Whilst every care will be taken when returning your licence by post, CAAS shall not be held liable if the licence is lost, delivered late or damaged in the post.
