## REVISED BILLING SCHEDULE FOR THE COLLECTION OF ROUTE AIR NAVIGATION SERVICES (RANS) CHARGES

**1 INTRODUCTION**

1.1 This AIC serves to notify aircraft operators, and all other stakeholders of the revised billing schedule for the collection of Route Air Navigation Services (RANS) charges by the Government of the Republic of Singapore on behalf and for the Government of the Republic of Indonesia from 01 March 2024 until 15 September 2024.

**2 REVISIONS TO BILLING SCHEDULE OF RANS CHARGES**

2.1 To cater time for changes to be made to CAAS' RANS charges system, there will be a revised billing schedule for bills issued by CAAS to operators for traffic operating in the airspace concerned in Jakarta FIR (refer to GEN 4.2 in AIP Singapore) for the months of March 2024 to July 2024 (refer to [Table 1](#)).

2.2 For traffic operating in the airspace concerned from September 2024 onwards, operators will be billed per the usual billing schedule, on a monthly basis, by the 15th of the following month.
