INFORMATION CIRCULAR

REVISION TO THE ASSISTANT/ FLYING INSTRUCTOR (AFI/FI) CERTIFICATE

1 This Information Circular serves to inform industry partners and holders of a AFI/FI Certificate of the revision to the certificate to indicate the types of training that the holder is authorised to conduct as part of the privileges of the AFI/FI Certificate.

Assistant/ Flying Instructor (AFI/FI) Certificate

- 2 With effect from 14 March 2019, the AFI/FI Certificate will specify the "Training Authorisations" that a holder can conduct which leads to the qualification of a licence and/or rating. If the training authorisation is not endorsed in the certificate, then he/she cannot conduct that particular type of training. This, however, will not be stated under the "Limitations".
- 3 The following table explains the types of "Training Authorisations" and "Limitations" that may be endorsed in the AFI/FI Certificate:
