SINGAPORE CHANGI AIRPORT – PARTIAL CLOSURE OF TAXILANE R3, TEMPORARY CHANGES TO GROUND MARKINGS AND LIGHTING, AND TEMPORARY DOWNGRADE OF TAXILANE R2 AT TERMINAL 2

1 INTRODUCTION

1.1 This AIP Supplement is to inform airline operators and pilots of the partial closure of taxilane R3, temporary changes to ground markings and lighting, and temporary downgrade of taxilane R2 from 0100UTC 25 MAY 2021 to 2200UTC 29 NOV 2021 to facilitate construction works.

2 PARTIAL CLOSURE OF TAXILANE R3

- 2.1 Taxilane R3 behind aircraft stand F34 will be closed for construction works.
- 2.2 Enlarged location of work area on taxilane R3 is shown in Appendix A.

3 TEMPORARY DOWNGRADE OF TAXILANE R2

- 3.1 Taxilane R2 between junction of taxilane R1/R2/R3 and taxiway T will be downgraded from Code F to Code E.
- 3.2 Two "MAX WINGSPAN 65M" markings will be painted at the junction of taxilane R1/R2/R3 and junction of taxilane R2/taxiway T to provide a visual cue of the downgraded segment of taxilane R2. The location of the markings is shown in **Appendix B**.

4 TEMPORARY CHANGES TO GROUND MARKINGS AND LIGHTING

- 4.1 Due to the partial closure of taxilane R3, ground markings and airfield lighting will be revised/removed as follows:
- a. Aircraft stand lead-in line will be provided from taxiway T (towards South) directly into aircraft stand F35L;
- b. The existing "EOT F34, F35L, F36" on taxilane R3 will be removed and replaced with an "EOP F35, F35R, F35L, F36" on taxiway T;
- c. Taxiway centreline and lights on taxiway T (towards South), turning West into taxilane R3 will not be available.
- 4.2 A schematic showing the existing markings and the revised markings are as shown in **Appendix C**.






Appendix B MAX WINGSPAN 65M MARKINGS ON THE DOWNGRADED SEGMENT OF TAXILANE R2


