SINGAPORE CHANGI AIRPORT – CLOSURE OF RUNWAY 02R/20L, TAXIWAY CLOSURES AND RESTRICTIONS

1 INTRODUCTION

1.1 This AIP Supplement informs aircraft operators and pilots of closure of Runway 02R/20L, taxiway closures and taxiways restricted for use by the Republic of Singapore Air Force (RSAF) only at Singapore Changi Airport from **16 May 2024, 0000UTC to 31 October 2024, 2359UTC**.

1.2 Please refer to **Annex A** for the location layout of the closed areas and taxiways restricted for RSAF use. The closed areas will be demarcated by barricades and supplemented with closure visual aids.

2 CLOSURE OF RUNWAY 02R/20L

2.1 There will not be any scheduled maintenance closures and inspections on Runway 02R/20L during the closure period.

2.2 White runway closed markings will be displayed on the pavement surface at intervals along the entire length of the closed runway, except where the pavement surface is under construction. In addition, a flashing white lighted cross will be placed at each end of the closed runway. Runway threshold, designator and touchdown zone markings will be removed. Approach and runway lighting will cease to operate.

3 CLOSURE OF TAXIWAYS AND TAXIWAYS RESTRICTED FOR RSAF USE

3.1 Details of taxiway closures and taxiways restricted for RSAF use are tabulated below.

3.2 The barricades on closed taxiways will have omni-directional fixed red lights that will be lighted at night and in low visibility conditions.

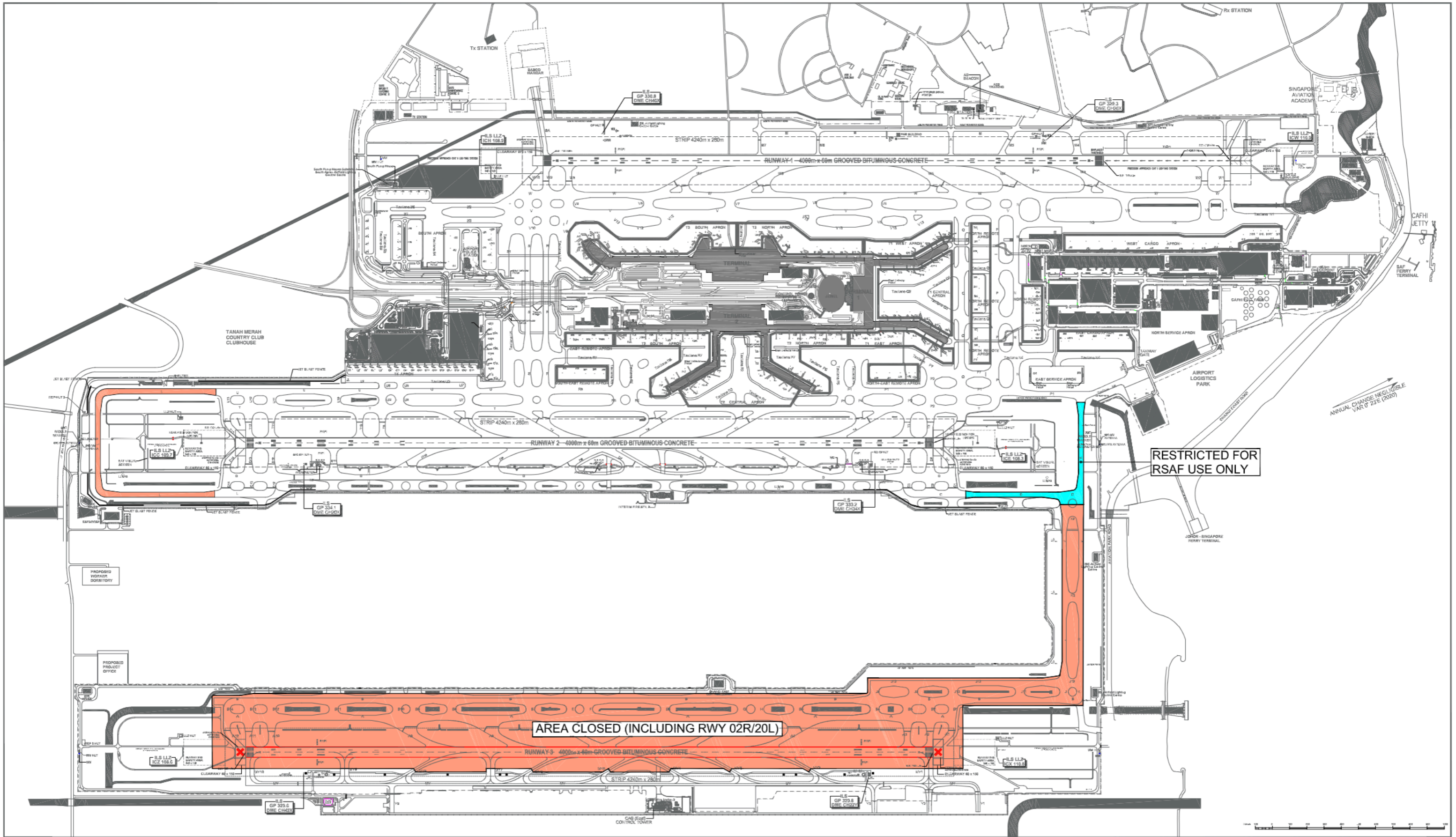
3.3 Taxiway centreline lights leading to the closed taxiways will not be in use.
