GENERAL

Pursuant to paragraph 88B of the Air Navigation Order, the Director-General of Civil Aviation (DGCA) may, from time to time, issue advisory circulars (ACs) on any aspect of safety in civil aviation. This AC contains information about standards, practices and procedures acceptable to CAAS. The revision number of the AC is indicated in parenthesis in the suffix of the AC number.

PURPOSE

This AC provides the list of aircraft types that may be endorsed in a Singapore flight crew licence.

APPLICABILITY

This AC is applicable to all flight crew seeking an endorsement of an aircraft type in a Singapore flight crew licence.

RELATED REGULATIONS

This AC relates specifically to Regulation 17 of ANR-119.

CANCELLATION

This AC supersedes AC FCL-4(4) dated 1 August 2018. In this revision 5, the A321-neo variant is included under the licence endorsement for the Airbus A320.

EFFECTIVE DATE

This AC is effective on 8 January 2021.

1 BACKGROUND

1.1 The privileges of a Singapore flight crew licence may only be exercised for the group of aircraft or in an aircraft type as specified in the aircraft rating of the licence, in conjunction with a valid Certificate of Test or a valid Certificate of Experience (for flight crew licences only). The aircraft ratings and the conditions under which such ratings may be endorsed in a Singapore licence are specified in this AC.

2 AIRCRAFT TYPES ENDORSED IN THE SINGAPORE FLIGHT CREW LICENCE

2.1 Subject to paragraph 3, the following aircraft types may be endorsed in a Singapore Flight Crew Licence:

Aeroplanes with single piston engine

- 2.2 A licence endorsement will be valid for the variants or similar types indicated in the tables above, i.e. no separate licence endorsement is required for the included variants. However, the pilot needs to complete a CAAS-approved differences course with the employer to fly another variant or similar type within the same licence endorsement.
- 2.3 Flight crew members who already have aircraft types that are not specified in paragraph 2.1 endorsed in their licence may continue to exercise their privileges of those aircraft ratings provided the Certificate of Test or Certificate of Experience is valid.
- 2.4 The following group ratings may be endorsed in a Singapore Private Pilot Licence:
 - All Single-engined aeroplanes (landplanes) under 5700 kg MTMA (Group "A").
 - All Multi-engined aeroplanes (landplanes) under 5700 kg MTMA (Group "B").

3 ENDORSEMENT OF AIRCRAFT TYPES NOT ON THE SINGAPORE REGISTER

- 3.1 CAAS normally endorses only aircraft types that are on the Singapore register in a Singapore flight crew licence. However, CAAS may also permit the endorsement of aircraft types in a Singapore licence in respect of aircraft types which are not on the Singapore register, but are accepted for flight training and tests in a CAAS approved Aviation Training Organisation (ATO) located overseas.
- 3.2 An applicant seeking such an aircraft type rating endorsement must enroll in the CAAS-approved overseas located ATO and complete the required training. The applicant is also required to pass the relevant CAAS ground examinations and flight tests to qualify for the aircraft type endorsement sought.
