Purpose To raise awareness among crew and ground staff the potential fire

hazard of the Samsung Galaxy Note 7 mobile phone.

Background Recently, there had been several news reports of the Samsung

> Galaxy Note 7 mobile phone exploding or catching fire. The probability of exploding is higher when the phone is being charged. Initial investigation by Samsung suggests that the events had resulted from defective lithium batteries installed in these handsets

and Samsung has recalled some 2.5 million phones globally.

Regulatory **Obligation**

Regulations on the use of portable electronic devices on board an

aircraft are specified in AOCR Chapter 7, Paragraph 2.8.

ANO Part VB, Paragraph 50E(1) read with the Nineteenth Schedule Part II, Paragraph 1, specifies that air operators must verify that dangerous goods consignments comply with the requirements of

ICAO TI prior to accepting them for carriage by air as cargo.

ICAO TI Special Provision A154 specifies that lithium batteries, identified by the manufacturer as being defective for safety reasons, or that have been damaged, that have the potential of producing a dangerous evolution of heat, fire or short circuit are

forbidden for transport (e.g. those being returned to the manufacturer for safety reasons).

Recommendation(s)

Taking into consideration the fire risk posed by Samsung Note 7 phones onboard an aircraft, air operators are recommended to:

- 1. advise passengers carrying the Samsung Galaxy Note 7 to refrain from using or charging the device onboard the aircraft;
- 2. raise awareness among crew members of the risk involved.
- refresh crew members with the knowledge on the application of emergency procedures¹ to deal with battery or PED fire / smoke in the cabin;
- 4. take necessary action to ensure that cargo consignments containing recalled Samsung Galaxy Note 7 handsets installed with potentially defective batteries are not offered for transportation by air.
