

INFORMATION CIRCULAR

WAIVER OF FEE INCREASE FOR CERTAIN REGULATORY ACTIVITIES APPLICABLE FROM 1 APRIL 2023 TO 31 MARCH 2024

- This Information Circular informs aviation organisations of the waiver of the fee increases for certain regulatory activities that are applicable for the period from 1 April 2023 to 31 March 2024 ("waiver period").
- 2 In exercise of his statutory power under paragraph 77(3) of the Air Navigation Order (ANO), the Chief Executive of CAAS has waived the fee increases specified in Table 1 for the following approval types:
 - (a) Singapore Airworthiness Requirements (SAR) Part 145 Approved Maintenance Organisation (AMO);
 - (b) SAR Part 21 Design and Production Organisations Approval (DOA/POA);
 - (c) SAR Part 21 Design Approvals (including Supplemental Type Certificate (STC) and Singapore Technical Standard Order Certificate of Approval (STSO)); and
 - (d) Singapore Air Operator Certificate (AOC).
- As such, for the waiver period, approval holders or applicants specified in Table 1 will be charged the relevant fees indicated in Column 2 of Table 1 i.e. based on the fees applicable from 1 April 2019 to 31 March 2020.
