#### **REGISTRATION FOR AVIATION ENGLISH COMPETENCY TEST IN YEAR 2015**

- 1 CAAS has arranged with the Regional Language Centre (RELC) to conduct the Aviation English Competency Test (AECT). This test is open to any holder of a Singapore professional pilot licence, private pilot licence or flight engineer licence who has not attained the ICAO Level 6 proficiency for English Language. For more information on the language proficiency test (AECT), please refer to Appendix 1.

- 4 Applicants must make reservation with RELC not less than 2 weeks before the intended date of taking the AECT. Reservation is on a first-come first-served basis and each session can take up to a maximum of 8 test applicants only.

5 Candidates are required to complete a registration form and make payment at RELC on the day of their test. Payment is to be made directly to RELC by either cash, Visa or Mastercard only. The test fee, as stipulated by RELC, will be charged as follows:

### **Conduct of AECT**

- The AECT is conducted as a 20-minute interview to determine the specific language proficiency level of the candidate. The test is conducted by two CAAS-authorised testers. Candidates who are required or intend to take the AECT are to contact Regional Language Centre, exams@relc.org.sg, to make arrangements to take the test.
- 2 The test comprises the following three parts:

# Part 1: Introduction (5 minutes)

In this segment, the candidate will be asked a few questions about himself and work. The aims are to establish rapport with the candidate and to serve as a warm-up for the next two segments.

# Part 2: Situational Talk – English Language (10 minutes)

In this segment, the candidate will be asked to explain in English language how he would react in a particular situation, such as a medical emergency during flight, or engine fire prior to descent. The tester will engage the candidate by posing the selected situation and may prompt the candidate, if necessary, during the discussion. The aim is to test the candidate's use of natural language rather than to seek a correct response to the given situation.

#### Part 3: Closing (5 minutes)

In the final segment, the tester will engage the candidate on an aviation-related topic before bringing the interview to an end. The focus of this segment is on the use of English language.

- 3 During the test, candidates will be assessed in the following six areas:
  - (a) Pronunciation (includes an accent that is internationally intelligible);
  - (b) Structure (relevant grammatical structures and sentence patterns);
  - (c) Vocabulary (a wide range of vocabulary which is appropriate to the situation);
  - (d) Fluency (includes spontaneity and appropriate speed of delivery);
  - (e) Comprehension (includes ability to listen and understand others); and
  - (f) Interactions (includes ability to manage the speaker-listener relationship effectively).

The overall language proficiency rating is based on the level reached in the candidate's weakest area. Failure to comply with descriptors in one category at a particular level indicates that the next lower proficiency level will be awarded. For instance, a candidate who is rated Level 4 for the category of Pronunciation but is rated Level 5 for all other categories will be given an overall proficiency rating of Level 4. Hence an individual must demonstrate proficiency at Level 5 in all categories in order to receive a Level 5, and so on for other higher levels.
