In exercise of the powers conferred by section 28A(2) of the Air Navigation Act, the Minister for Transport makes the following Rules:

#### **Citation and commencement**

1. These Rules are the Air Navigation (Composition of Offences) Rules 2017 and come into operation on 24 November 2017.

#### **Composition by authorised public officer**

2. The following offences may be compounded by any public officer authorised in that behalf by the Minister in accordance with section 82(5)(a) of the Act:

- (a) an offence under paragraph 6(5), 7(6), 8(4), 13, 17(5)(a), 18(5)(b) or 20(2) of the Air Navigation (Aviation Security) Order (O 5);
- (b) an offence under paragraph 10(3), 13(2), 14(2), 16(3) or 18 of the Air Navigation (Regulated Air Cargo Agents) Order (O 8) as in force immediately before 15 May 2017;

- (c) an offence under regulation 11(2), 11A(2), 16(2), 19(4) or 19C(2) of the Air Navigation (Regulated Air Cargo Agents and Known Consignors) Regulations 2017 (G.N. No. S 166/2017);
