In exercise of the powers conferred by section 3 of the Civil Aviation Authority of Singapore Act 2009, the Minister for Transport, after consultation with the Civil Aviation Authority of Singapore, hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Civil Aviation Authority of Singapore (Changi Airport) Notification 2009 and shall come into operation on 1st July 2009.

Area declared as Changi Airport

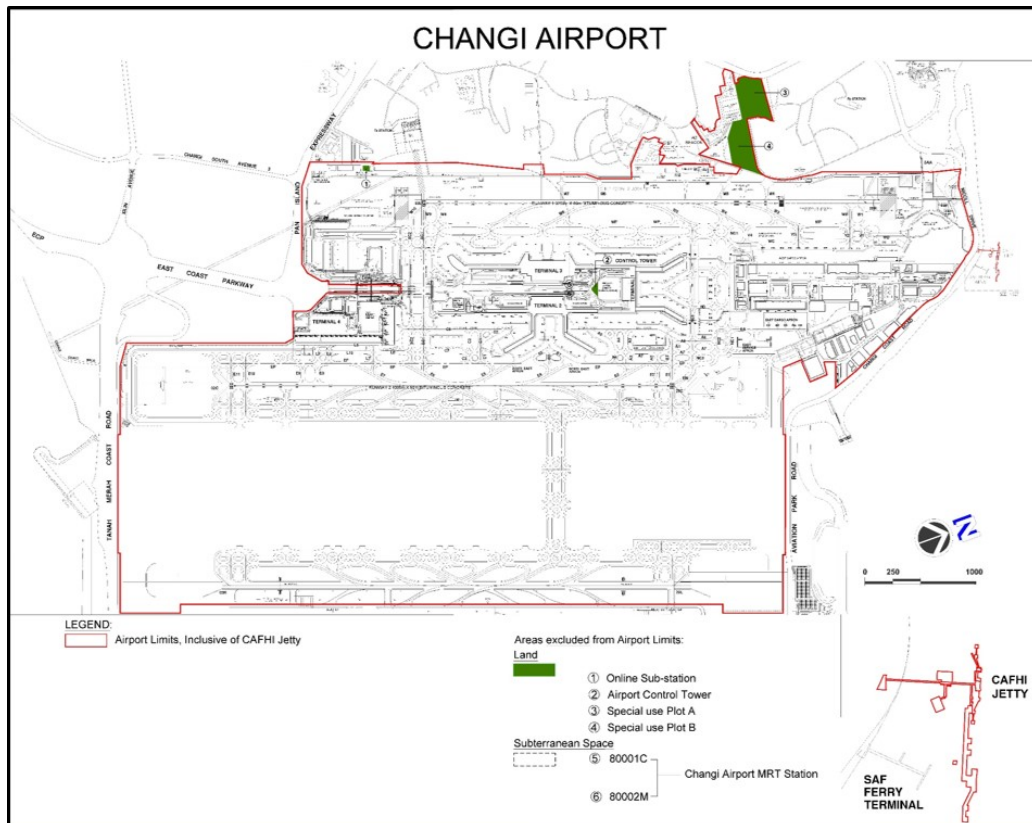
2. The lands and waters in Singapore described in the Schedule, including all roads, buildings, installations, and equipment therein, are hereby declared to be an airport, known as Changi Airport, for the purposes of the Act.
