In exercise of the powers conferred by section 102(2)(e) of the Civil Aviation Authority of Singapore Act 2009, the Civil Aviation Authority of Singapore, with the approval of the Minister for Transport, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Civil Aviation Authority of Singapore (Composition of Offences) Regulations 2009 and shall come into operation on 1st July 2009.

Compoundable offences
