Enhanced Regulatory and Permit Framework for the Use of Unmanned Aircraft in Singapore

15 May 2015, Singapore Aviation Academy

The use of unmanned aircraft is becoming increasingly popular. Today, unmanned aircraft are used for a range of purposes, such as the delivery of goods, aerial filming and photography, search and rescue and inspection of infrastructure and facilities. Given Singapore's busy airspace and densely populated urban environment, the flying of unmanned aircraft must be carried out in a safe and responsible manner. If not carried out properly, the operation of unmanned aircraft may pose a risk to aviation and public safety and security.

An enhanced regulatory and permit framework for unmanned aircraft operations in Singapore will be introduced to facilitate their usage while mitigating the associated aviation safety, public safety and security risks. The enhancements are expected to take effect on 1 June 2015 after the necessary legislative processes are completed.

At this seminar, speakers from CAAS will share details of the enhanced regulatory framework and permit regime with participants. Attendees will be informed of the key proposed changes to the regulatory framework. Guidance will also be provided on the types of unmanned aircraft operations that would require a permit under the permit regime.
