## REGISTRATION FOR WORKSHOP CERTIFYING STAFF EXAMINATIONS AND NON-DESTRUCTIVE TESTING APPROVAL EXAMINATIONS (JAN 2014 TO MAR 2014)

- The examinations provided in the table below are only for the purpose of qualifying workshop certifying staff in accordance with AC 145-2. Examination credits obtained from the examination sessions listed in this table and any subsequent sessions administered will not be accepted as credits towards the grant of an aircraft maintenance licence. Those seeking to qualify for a SAR-66 aircraft maintenance licence are advised to take the SAR-66 examinations.

- The SAR-7 subjects H11 (Human Factors & Error Management) and L11 (Air Legislation) examinations have been superseded by SAR-66 modules M09 and M10 respectively. Applicants for these SAR-66 examinations may register and book online via the CAAS website. As a guide to those applying for SAR-66 examinations, module numbers bearing suffix "B1" are for workshop certifying staff in the Mechanical category, and those bearing suffix "B2" are for workshop certifying staff in Avionics category.
