

APPLICATION FOR PERMIT TO CARRY MUNITIONS OF WAR BY AIR

Instructions to Applicants

- 1. Applicants are required to complete this application form when applying for munitions of war permit, and submit it to CAAS no later than seven (7) days before the date of shipment.
- 2. An application for an **Ad-Hoc** Permit to carry munitions of war must be submitted to the parties listed below by post, fax or e-mail:

*Please note that applications for the permit to carry Munitions of War (for Sporting Purposes) need not be sent to PLRD.

- 3. Failure to complete this form in full will result in a delay in processing your application.
- 4. To obtain an **Ad Hoc Permit**, applicants must submit the following supporting documents:
 - (i) Air Waybill
 - (ii) Shipping Invoice / Commercial Invoice
 - (iii) Import and Export License (For import/export/transhipment of MOW to, from or through Singapore, attach the "Singapore Police Force Request Form for Import/Export/Transshipment of Arms and Explosives." with approval granted by PLRD)
 - (iv) End-User Certificate
 - (v) Dangerous Goods Shipper's Declaration (for munitions of war classified as dangerous goods)
 - (vi) Any other documents in connection with the carriage of munitions of war by the air should be duly submitted with along with this application

5. An application for a **Block Permit** to carry munitions of war must be submitted by post, fax or e-mail to:

- 6. To obtain a **Block Permit**, applicants must submit the following supporting documents:
 - (i) Air Operator's Certificate (AOC).
 - (ii) Operations Specifications which states the Dangerous Goods Authorisation.
- 7. A fee of S\$45 per permit is payable upon the issuance of an Ad Hoc Permit.
- 8. A fee of S\$380 per permit is payable upon the issuance of a Block Permit.
- 9. Applicants granted with either an Ad Hoc Permit or a Block Permit to carry munitions of war must comply with the following:
 - (i) If the munitions of war are also classified as dangerous goods, the holder of the permit must comply with the provisions of Annex 18 to the Convention on International Civil Aviation and the current edition of the International Civil Aviation Organization (ICAO) Technical Instructions for the Safe Transport of Dangerous Goods by Air as well as Paragraph 50D of the Air Navigation Order (ANO).
 - (ii) The holder of the permit shall immediately notify Airport Emergency Service Division of any dangerous goods incident or accident by telephone at +65-6541 2525, and submit a report to CAAS using CAAS form AW139 Part 4 to this email address at <u>caas dfirs@caas.gov.sg</u> within 24 hours of the incident/accident. The holder of the Permit shall follow up with a detailed investigation report, within 14 days of the incident/accident occurring, containing the sequence of events that caused the incident/accident and the corrective measures taken to prevent a recurrence of such incidents/accidents.
- 10. The Permit may be withdrawn without notice in the event of a violation of any of the conditions or regulations mentioned above.

- 11. Successful applicants of an **Ad Hoc** Permit must note the following:
 - (i) To submit a notification form attached hereto as <u>Form A</u> to CAAS upon completion of the flight.
 - (ii) To use the Ad Hoc Permit on a single return flight within its validity period of 2 weeks.
- 12. Successful applicants of a **Block** Permit, must note the following:
 - (i) To submit a monthly summary report attached hereto as **Form B** to CAAS at "CAAS_dangerousgoods@caas.gov.sg" not later than ten (10) days from the end of each month to which the report relates. A "nil" return is necessary.
 - (ii) To retain all detailed records of munitions of war consignments for at least 3 months after the date of carriage and produce these records to CAAS for inspection as requested.
 - (iii) To obtain all necessary consent from the competent authorities of the States as they may impose restrictions on the carriage of munitions of war on an aircraft that flies over the States in the course of its journey, or on the territory of which it may land.
 - (iv) To use the Block Permit within its validity period of 6 months.
 - (v) To submit a separate application to CAAS for renewal of a Block permit.
