## **Safety Management System – Framework For The Establishment of Safety Performance Indicators For Approved Maintenance Organisations**

18 October 2016, Singapore Aviation Academy

ICAO Annex 19 requires service providers to implement a Safety Management System (SMS) that commensurate with the size and complexity of their aviation products or services. The ICAO SMS framework also requires the safety performance of an organisation's SMS to be verified with reference to the safety performance indicators (SPIs) and safety performance targets (SPTs) established by service providers.

The AMO sector is highly diverse in terms of complexity and size. It is a challenge for the AMO sector when identifying the SPIs without first establishing a common procedure that could account for the diversity. In this seminar, CAAS will provide an overview of the proposed SPI framework for the AMO sector which is planned to be released in the form of an Advisory Circular end of October 2016. We will also be sharing about the proposed data collection process, and the task of safety performance review.
